**SPOUSE PREFERENCE INFO:** Only **military spouses** are entitled to Spouse Preference (Priority III-A). A military spouse may be given preference only **ONCE** during his/her tour in Sasebo. The military spouse **MAY NOT CHOOSE** when to use Spouse Preference. If the military spouse has accepted or declined a permanent or a temporary position that is at least one year in duration with HRO, MWR or NEX, that individual is no longer eligible for Spouse Preference. A Spouse Preference who accepts a temporary position for less than 1 year and is terminated or resigns before completing 1 year may retain Spouse Preference status. However, if that individual is subsequently extended BEYOND 1 YEAR in the same position, without a break in service, he/she can also lose Spouse Preference status. **Once Spouse Preference has been used, that individual will be referred in the same category (Priority III-B) as Civilian and other Family Members.** Qualified Spouse Preference (Priority III-A) and other lower priority applicants may be blocked by a qualified 5 or 10pts veteran (Priority I or II).

Before you sign below, make sure you clearly understand the requirements or rules on Spouse Preference, veteran preference, and other appointment eligibility that pertains to you. Please ask HRO staff if you have any questions.
